- In this meeting the information regarding upcoming international RRC to the Central Europe was given and explained by the Chairperson Ruta Chitale . The dates of International RRC were 10^{th} August to 27^{th} August..
- The most important subjects were Problems faced by the students as well as Members due to "SSP" new software portal which is launched by ho and practically no control in the hand of branch.

Ca Abhishek Zaware informed about many students are facing problems due to ssp and he is getting many calls as well as messages. Ca Amruta also informed the same thing. In fact every member present in the meeting are getting such calls and everyone is trying to resolve the issues.
